#### **USER AGREEMENT**

This agreement defines the terns for the use of the site http://kompozit-ut.ru (hereinafter referred to as the site) materials and services by site visitors (hereinafter referred to as users).

By browsing the site's pages and using its services, users agree to the terms of this User Agreement (hereinafter referred to as the Agreement), including the privacy policy and the procedure for collecting and processing the site's personal data by the site administration.

The site administration has the right at any time to change the terms of the Agreement unilaterally, while the new edition of the Agreement comes into force from the moment it is posted on the site, unless otherwise provided for in the terms of the Agreement in the new edition. #### **Attendance Statistics**

The site uses automated tools designed to collect anonymous statistics on visits. They include information about the IP address, provider, browser, screen resolution and operating system installed on the technical means (computer, phone, etc.) of users. In addition, the journal stores information about the source pages of the transition to the site.

To collect statistics, the site administration uses third-party statistics collection systems Google Analytics and Yandex-Metric.

Respecting the right of users to confidentiality, the site administration does not use automatically collected data to identify the user's identity, communication with him, does not publish them. The purpose for collecting statistical data is to ensure the site security, improve it, optimize the speed of work and increase its convenience for users.

#### **Cookies**

## Goods and services (work)
